5. Principals report –Terry Ainge

School district proposed budget went public last week.

Public consultation night was last night.

Large cash shortfall including a shortfall from last year. Will impact DSS.

Staffing will need to be reduced. Enrolment is down about 80 students for this September. Will be under 1200 students. Grade 8 coming in is 180. First class under 200 in years. Grade 11 will be 210 (last year was 300).

Academies are strong, that has helped with out of district registration.

Per pupil amount is increased by over \$100 but other costs have risen as well, such as teacher pension funding increases.

Seismic upgrading: DSS is on the list for 2014/2015. Library taken off the list for upgrades. Theatre is on list, and some of the surrounding areas such as shop. Aprox \$18,700,000 project. Start date after July 2014.

As library is not scheduled for upgrades we can consider doing upgrades that we have been putting off. Librarian has prepared submission requests.

Last day of school June 14, 2013. Same day as school dinner dance.

Terry would like to do early dismissal, PAC agreed.

Next years Grad, June 8 is available. Nothing set at this point.

6. Pre-Budget discussion

Teacher requests for gaming funds submitted, total comes to over \$45,000.

Needs to be reviewed and reduced. Income from gaming will be approximately \$28,000.00

Request by Terry to add Student recognition awards. Last year budget was \$5,000.00.

Fundraising

The fundraising is nearly complete with just the liquor store fundraiser results to be received. The committee did exceptionally well raising over \$50,000 for Dry grad – still pending final totals for Grand Raffle, tshirt sales and Liquor Store funds

Parent Contributions (as part of above total) were **\$12,500** so 125 parents out of approx 300 graduating students

Expenses

The final budgeted expenses are \$54,268 which include \$5900 for seed money for 2014 Dry Grad.
